#### What we do . . .

- Maintain public and stakeholder contacts on all major projects:
  - Newsletters and other direct mail
  - Public open houses
  - Hands-on one-on-one contact with local officials
- Selective corporate sponsorships at local level
- Advertising (project and corporate)
- Speak to many local groups (tied to 10-Year Assessment distribution)



#### Major 345 kV Projects

- Rockdale-West Middleton (Dane County)
  - County-wide referendum on "independent study" passed ("but ATC's polling shows ...")
  - Undergrounding options
  - Final routes, open houses, CPCN this summer, and strong public support for Beltline
- Rockdale-Paddock (Dane & Rock Counties)
  - Project open house scheduled for March 6 & 7.
  - CPCN filing scheduled for April 2007.



## Major 345 kV Projects (cont'd)

- Gardner Park-Central Wisconsin & Morgan-Werner West
  - CPCN Order: June 2006
  - Pre-construction open house held December 5 in Shawano County.
  - Real estate negotiations ongoing.
  - Construction & Mitigation Plans developed.
  - Minor Route Adjustments developed.
  - Laydown areas being constructed.



#### Major 138 kV Projects (Dane)

- Fitchburg (Oak Ridge)-Verona:
  - CPCN filed in December 2006 and already deemed complete.
  - Negotiations continue with City on Oak Ridge Substation site.
  - Local intervenor groups still organizing.
- N. Madison-Huiskamp (Waunakee):
  - PSCW hearings completed.
  - Many intervenors; little real impact in the end.
- Femrite-Sprecher:
  - Complete!



## Major 138 kV Projects (cont'd)

- Cranberry-Conover-Iron River-Plains:
  - CPCN Order: November 2006
  - First construction spread: Eagle River to Conover
  - Real Estate work beginning.
  - Minor route adjustments developed.
  - Vilas County Forest
- Jefferson County :
  - CPCN Order: August 2006
  - Judicial review requested by three parties: Jefferson County, impacted landowners, and the Madison Audubon Society.



## Major 138 kV Projects (cont'd)

- Venus-Metonga (Oneida & Forest):
  - Real estate negotiations continuing.
  - Pre-Construction open house held in January in Crandon.





## "Major" 69 kV Projects

- Typically no PSC approvals required, but . . . local zoning applies.
- ATC projects initiated requiring new 69 kV rightof-way (each T-D related):
  - Fitchburg-Oregon (Dane)
  - Tomah-Warrens (Monroe)
  - Sauk Prairie (Sauk)
