Major 345 kV Projects

Rockdale-West Middleton (Dane County)

- Underground options discussed at public open houses held June 11, 12, & 13, 2007.
- Final routes announced on August 1, 2007.
 - --Open houses held August 20, 21, 22, & 23, 2007.
 - --CPCN application filed on October 16, 2007.
- Considerable public interest and visibility.
- PSCW review of ATC's responses to 11/15/2007 Incompleteness Determination continues.



Major 345 kV Projects (cont'd)

- Paddock-Rockdale Line (Dane & Rock Counties)
 - "Access" project to facilitate MISO regional market
 - Project open houses held March 6 & 7, 2007.
 - CPCN application filed May 16, 2007.
 - Public hearings held on February 13, 2008.
 - CPCN expected to be issued by May 2008.



Major 345 kV Projects (cont'd)

- Gardner Park-Central Wisconsin & Morgan-Werner West Lines
 - Pre-construction open houses held in Marathon County on July 11, 2007; in Bear Creek on February 12, 2008.
 - Real estate negotiations ongoing.
 - Various line segments and substation sites under construction.
 - The projects are on schedule to meet their planned in-service dates of December 1, 2009.



Major 161 kV Project

Nelson Dewey Generator Interconnect:

- Need to connect new unit to Mississippi River crossing with new 161 kV line.
- T-line public outreach and siting in full swing.
 - --Village of Cassville second open house held on November 14, 2007.
 - --Upcoming Alliant open house with ATC present March 3, 2008, in Cassville.
- Routing and siting continue in preparation for submittal of a CPCN application in July 2008.



Major 138 kV Projects (Dane)

Fitchburg (Oak Ridge)-Verona:

- CPCN issued on January 23, 2008.
- Proceeding with substation site acquisition, accepted option to purchase city property;
- Oak Ridge Substation in service June 2009, T-Line in service June 2010.

• N. Madison-Huiskamp (Waunakee):

- CPCN issued on July 20, 2007.
- Real estate acquisition and substation construction in progress, T-Line work in the fall, in service by end of 2008.



Major 138 kV Projects (cont'd)

- Cranberry-Conover-Iron River-Plains (Vilas, Forest, Florence—and UP Michigan):
 - CPCN issued: November 2006
 - Underground segment complete except for cable pulling.
 - Line crossing of Twin Lakes near Conover completed in December 2007.
 - USFS decision on crossing of Elvoy Creek wetland pending.

Jefferson County:

- Still awaiting PSCW decision on NEV study and proposal.
- T-Line Construction scheduled to begin in September 2008.
- Installed capacitor bank at Boxelder Substation to get through summer peak.



"Major" 69 kV Projects

- Typically no PSC approvals required, but ... local zoning applies.
- ATC projects initiated requiring new 69 kV right-of-way (each T-D related):
 - Fitchburg-Oregon-Sun Valley SS (Dane)
 - Tomah-Warrens (Monroe)
 - Sauk Prairie (Sauk)
