#### 1 PURPOSE

To ensure public safety and continuity of reliable electric transmission service, ATC will support customers' house moves by coordinating the process, roles, and responsibilities for house moves that affect ATC's facilities. This Business Practice provides this guidance for a house move under or adjacent to ATC's transmission lines.

## 2 SCOPE AND APPLICABILITY

In its attention to public safety, reliable transmission service, and the National Electric Safety Code (NESC), ATC must carefully review safe clearance requirements with respect to the proposed house move and answer the following:

- 1. Will the proposed house move impact ATC facilities?
- 2. If so, are transmission line outages necessary?
- 3. If not, does ATC need only to assign utility oversight of the house move?

ATC requires a minimum of three (3) weeks to perform this necessary review of the proposed move, additional time maybe required if ATC facilities require adjustment as a result of the move. If ATC's review determines that ATC will be impacted, ATC will work with the requestor to establish a firm move date that enables sufficient (especially if including line outages) lead time for preparing ATC's work. In its review, ATC considers several factors when reviewing a house move including, but not limited to:

- 1. Affected line(s') voltage. The NESC requires specific clearances between overhead electric conductors, including ATC's high voltage transmission lines, and any grounded objects, including the house to be moved and/or the ground itself. Higher voltage lines require greater clearances to minimize the safety and reliability risk of flashover.
- 2. *Time of year.* The more power a line carries, the more it heats up and the lower it sags as the aluminum expands. Typically a line will sag the most on a hot summer day and the least on a cold winter night. The time of year and even the time of day can be the difference between needing to take a line temporarily out of service and simply monitoring the activity as the house passes under a live line.
- 3. Real-time conditions. If a line outage is required, ATC real-time transmission system conditions (for example, weather conditions or heavy electric flows on the transmission system) will dictate if and when the house move can occur. ATC continually monitors such conditions and reserves the right to delay or reschedule a planned house move line outage up to and including the day of the house move. The likelihood of this possibility can be significantly minimized by carefully considering ATC's input on the house move schedule with respect to the time of year and day.

The following is ATC's process for conducting a house move

- 1. The customer shall complete and submit to ATC a "Request to Move a House under ATC Transmission Lines" form (Exhibit 1) together with a suggested route map.
- 2. ATC will study the request and determine the impact of the house move on ATC transmission lines. There is no charge to the requestor for this initial study.
- 3. ATC will respond to the requestor in writing with any ATC transmission equipment outage requirements and estimated costs associated with the house move.
- 4. The requestor shall affirm to ATC whether or not they will proceed with the house move. If the requestor will proceed with the move, ATC requires a minimum of three (3) weeks from the time ATC is notified of the final move date to schedule and coordinate ATC's work due to the house move
- 5. At this time ATC will forward the "Agreement for Payment for a House Move under American Transmission Company Facilities" (Exhibit 2) to the requestor.

- 6. The requestor shall execute the Payment Agreement and return it to ATC together with payment for ATC's estimated cost for its work due to the house move. ATC will only be able to perform their work due to the house move if ATC receives the agreement and payment prior to the house move date.
- 7. Within ninety (90) days of completion of the house move, ATC will calculate its actual expenses incurred for work due to the house move and render a final statement to the requestor.
  - a. In the event that the Requestor's advance payment exceeds the actual costs incurred by ATC, ATC will reimburse the Requestor for the overpayment within thirty (30) days of the date of the final statement.
  - b. In the event that ATC's actual costs and expenses incurred in performing the work exceed the Requestor's advance payment, ATC will submit an invoice to the Requestor. The Requestor shall pay the additional costs incurred by ATC in performing the work within thirty (30) days after the date of ATC's final statement.

## 3 ROLES AND RESPONSIBILITIES

ATC's Real Estate Department will coordinate the process among the requestor, local distribution utility and the appropriate ATC departments.

The assigned Real Estate Representative for this House Move Business Practice will meet with internal parties to build consensus when changes to the business practice are necessary. The assigned Real Estate Representative will edit the business practice using the track changes feature in Microsoft Word. The proposed revisions will be submitted to the Customer Relations -Customer Communications Coordinator for grammatical review and improvement. The document will then be forwarded to the Customer Relations – Interconnection Services Director signature and subsequent publication.

## 4 ADDITIONAL INFORMATION

ATC will continually strive to provide safe transport of houses or other large items beneath ATC owned equipment.

## AGREEMENT FOR PAYMENT FOR A HOUSE MOVE UNDER AMERICAN TRANSMISSION COMPANY FACILITIES

This Agreement is made by and between the AMERICAN TRANSMISSION COMPANY LLC, a Wisconsin limited liability company, (hereinafter "ATC"), and [Owner, and Address] (hereinafter "OWNER").

#### WITNESSETH:

WHEREAS, ATC owns transmission facilities located at [Description, County, State] (hereinafter the "Parcel"), and

WHEREAS, OWNER has requested ATC to [Describe Work] for OWNER'S own purposes, and

WHEREAS, ATC is willing to [Describe Work] to accommodate OWNER (hereinafter the "Work") on the following terms and conditions.

NOW THEREFORE, it is mutually agreed as follows:

- 1. ATC, through its contractors and agents, shall perform the Work on the Parcel as requested by OWNER, and as further described in Attachment A attached hereto and made a part hereof.
- ATC shall procure all licenses and permits required to perform ATC transmission Work. The ATC transmission Work shall be performed consistent with normal utility practices, and shall comply with all applicable Federal, State and local laws and ordinances, and the Wisconsin Administrative Code.
- 3. ATC shall de-energize Existing Facility as set forth and further described in Exhibit A. <a href="Owner acknowledges and understands that the Existing Facility">Owner acknowledges and understands that the Existing Facility is an element in the Eastern United States integrated transmission system and that outages on the Existing Facility require the consent of the Midwest Independent System Operator (MISO). Owner further acknowledges and understands that MISO may order that the Existing Facility be re-energized at any time for reasons beyond ATC's control. In the event the Existing Facility must be re-energized, ATC will notify Owner, and Owner agrees immediately to cease its operations in the vicinity of the Existing Facility and vacate the area so that the Existing Facility may be re-energized. Owner further agrees that it will be responsible to reimburse ATC for all costs and expenses associated with any unplanned switching event. Owner also acknowledges that it will be liable for additional costs per the Rights and Remedies clause below in the event of a failure to be clear of the line by the scheduled end of the outage period, or within the time period stated in the work plan in the event that the line needs to be re-energized.

DWNER shall reimburse ATC all Direct and Indirect costs and expenses incurred by ATC in performing the Work. Direct costs include labor, employee expenses, material costs and outside contractors. Indirect costs include Labor, Management,
Organizational Support, Incentive and Project Administration Clearing Loadings. The estimated cost to perform the Work
shall be \$, which amount shall be paid to ATC prior to the commencement of the Work. After the Work
s completed, ATC shall calculate its actual expenses incurred in performing the Work, and shall render its final statement to
DWNER within ninety (90) days of completion of the Work. In the event that ATC's estimate has been remitted in full to
ATC by OWNER, and the estimate exceeds ATC's actual costs and expenses incurred in performing the Work, ATC will eimburse OWNER for the overpayment in costs and expenses within thirty (30) days of the date of the final statement. In the event that ATC's actual costs and expenses incurred in performing the Work exceed the estimate, OWNER will reimburse the additional costs and expenses incurred by ATC in performing the Work within thirty (30) days after the date of ATC's final statement.
